Stichting Terre des Hommes Foundation (STdHF) is a not-for-profit company founded with the mission to "prevent child exploitation, remove children from exploitative situations and ensure that these children can develop themselves in a safe environment". We are registered under Section 8 of the Companies Act, 2013 in India, working towards a vision to see a world in which children are no longer exploited.

We envisage a world where all children have a decent life and can grow up to be independent adults. We will continue our work until this is accomplished. Our major purpose is "to support, carry out, disseminate knowledge and develop various interventions of Child Care Programmes in India and establish funds to revolve to attain economic independence of the families with children in distress". Therefore, our focus is on stopping child exploitation and the most serious violations of the rights of the child.



EDUCATION

- STdHF donated 200 baby chairs to 2 Anganwadi Centers and 7 Primary Schools in Tirunelveli and Tenkasi districts, Tamil Nadu.
- Two primary schools of the Tirunelveli district were supported to form a library setting for the children to enjoy reading.





- STdHF provided three laptops along with computer accessories to 40 Global English Learning (GEL) students from underprivileged backgrounds at Thiruvananthapuram, Kerala to access hassle-free learning during the Covid crisis.
- STdHF provided education support to 20 Devadasi girls in the form of books, fees, provision of tablets with Byju's software, and spoken English classes, to ensure the girls' academic progress in Bellary, Karnataka.
- STdHF also catered to the needs of high school and higher secondary school students in Hosur, Tamil Nadu, by providing educational materials and school students. 115 This baas to support has greatly contributed to their educational pursuits.



 70 school-going children from vulnerable families were supported with educational kits and materials in Gooty, Guntakal and Kalyanadurgam in the Ananthapuramu district, Andhra Pradesh.



- STdHF organised sports competitions across ten schools in the Tiruvarur district, Tamil Nadu for children studying in class 6 to class 8 from 20th to 27th March 2023. STdHF identified volunteers from among the elder children to coordinate the event. All the children who participated in the sports competitions were given certificates as a token of appreciation. 90 children who were the winners of various competitions, were given silver vessels. In addition, all ten schools were given sports items for an amount of Rs. 3000/- to ensure the children cultivate their sporting interests and talents.
- While addressing the needs of underprivileged students, STdH discovered that a government-aided private school in Chamrajanagara, Karnataka had a student population largely comprised of children from economically disadvantaged backgrounds. Their parents, who were daily wage labourers, struggled to afford notebooks and uniforms for their wards. Upon contacting the Headmistress of the school, and obtaining a list of materials required by the children, STDHF provided notebooks and stationery materials to 60 children to ensure hassle-free learning for them.



HEALTH

- Two physically handicapped persons from Sankarankovil Tamil Nadu were identified in the area and were supported with wheelchairs which would help them move easily without depending on a family member all the time.
- STdHF provided support to 31 people with physical challenges in Hosur, Tamil Nadu that will improve their quality of life by enabling them to become independent.





- Two water tanks with a capacity of 1000 litres each were donated to the Dalit colonies in Sankarankovil, Tamil Nadu, where the people did not have access to adequate drinking water supply. Each tank will be used to store 1000 litres of clean water for a couple of days which can be used by community members without facing any kind of discrimination.
- STdHF conducted a Health Camp where two physicians, one gynaecologist and a General Medical Doctor provided health consultation to 84 victims of child marriage in Chamrajanagara, Karnataka. The doctors prescribed medicines and tonics for headaches, cough, stomach pain, menstrual issues and anaemia.



- 80 school-going adolescent girls from underprivileged communities were provided with menstrual hygiene awareness and distributed sanitary napkins to ensure hasslefree education in Hosur, Tamil Nadu.
- STDHF conducted a Health Awareness Campaign in the working villages of Thisaiyanvilai, located in Tirunelveli district, Tamil Nadu. The campaign reached 9 villages and garnered significant participation from the local community and the public.
- STdHF organised a campaign on health and menstrual hygiene to 100 adolescent school students in Tirunelveli, Tamil Nadu. Teachers expressed their appreciation for the effectiveness of an awareness song focusing on physical health, mental health, sexual education, medical advice, and the symptoms of anaemia along with its treatment methods.
- As part of health and nutrition campaign, a showcase of traditional food and herbs from all the villages was organized in Erumaikulam, Tirunelveli, Tamil Nadu. The event featured 13 types of traditional medicinal foods and 18 types of food that have fallen out of common use. The participants learned about the health benefits, nutrients, and diseases that these herbs and foods can address, making it an impressive and innovative function.
- STdHF conducted a special health check-up on general health, eye care, and gynaecological well-being to ensure comprehensive health support to 100 women who are part of Self Help Groups in Belagavi, Karnataka.



LIVELIHOOD

 Mr Mahendran, a person with autistic conditions has been without any earnings for his livelihood. He has been dependent on his old parents and siblings. To make him selfreliant, it was decided that STdHF donated a petty shop for him to run independently in his village and earn a livelihood.





- 32,644 women were enrolled in 2,720 Self Help Groups and encouraged to save an average amount of Rs 500/ month in 5 southern states of India.
- Rs 4.64 crores were provided to 1897 members to improve their livelihood and increase their economic status in 5 southern states of India.
- 8160 representatives from Self Help Groups were empowered with leadership qualities as part of community-level sustainable growth.



• STdHF in collaboration with District Legal Services, the Department of Women and Child Development, and the Women Lawyers Guild celebrated Women's Day 2023 by organizing a legal awareness camp in the Belgavi district. 100 women from Self Help Groups participated in the event to learn about their rights and the legal framework that protects them. The women were oriented on various constitutional laws and privileges like the Domestic Violence Act, the Preconception and Prenatal Diagnostic Act, the Prevention of Child Marriage Act, and the Protection of Children from Sex Offenders Act.

M. Vaijeyanthi resides in Puliampatti village, of Tirunelveli district with her husband, Mr. Mahendiran, and two children. She's an active member of the Malligai SHG of STdHF diligently saving Rs.200 per month, accumulating Rs.5500 internally to run her scrap shop. Her Kerala scrap shop, where they buy and sell old items, generates daily profits ranging from Rs.500 to 3000. On 24.5.2023, she obtained a Rs.50,000 loan from STdHF to expand her business. These profits help support her family's needs and her children's education which she was earlier struggling to manage.



STORY HIGHLIGHT

Supreeta Ajaya Nayak, a 19-year-old orphan has faced numerous hardships in life. Married at the tender age of 13, she now resides with her In-Laws, Aunts, Husband, and two children in Khanapur Taluk.

Before the program implementation, Supreeta's husband, a driver, suffered a debilitating accident, leaving him with a non-functional right shoulder. Her father-in-law worked as a labourer, and they lived in a house at Indira Habitat, grappling with health issues. Supreeta endured menstrual cramps and anaemia, facing a lack of rights at home. Her husband's health issues and a devastating fire that consumed their home left her with nothing, forcing her to borrow to feed her family.

То break her free from impoverishment, the STdH team coordinators helped Supreeta start goat farming Despite initial setbacks when two baby goats died from diarrhoea, she persevered. Today, her goats are pregnant, and the venture has helped her pay off debts. Enrolled in the Self-Help Group, she relishes her newfound independence and acknowledges the program's role in transforming her life.

Before the intervention, Supreeta and her family struggled to afford even one proper meal a day. However, her determination and the support from the program enabled her to rise above adversity. Now, she expresses gratitude to STdH as it has reunified her family and empowered her to build a better future.
